Warga negara Inggris, lahir pada tahun 1966. Beliau memperoleh gelar Sarjana di bidang Quantity Surveying dari Nottingham Trent University (1989) dan kemudian menjabat sebagai Associate of the Royal Institution of Chartered Surveyors (1992) dan menjadi asesor untuk uji kompetensi profesional untuk pelamar RICS di Indonesia. Studi pasca sarjana beliau meliputi Diploma Manajemen Proyek dan MBA dari Reading University, Inggris (2006).

Mark pertama kali ke Indonesia pada tahun 1995, di mana ia pernah bekerja untuk Davis Langdon & Seah Indonesia (1995-1998), Stolt Comex/Komaritim (1998-1999), J.Ray McDermott (2002-2004) dan PTTEP (2005-2006). Selain di India, beliau pernah bekerja di Singapura, Malaysia, China, India, Venezuela, Dubai, Belanda dan Amerika Serikat antara lain dengan perusahaan seperti Bovis Lend Lease (1999-2002) dan Saibos Akogep (2004-2005). Sebelum bergabung dengan Sekar Group, beliau adalah Senior Project Controls Specialist di Total E&P (2006-2015). Saat bergabung dengan Sekar, beliau menjabat sebagai presiden direktur Bukit Welirang Indah (Finna Resort Redevelopment) (2016-2021) sebelum menjadi penasehat pemegang saham. Saat ini beliau juga menjadi perwakilan pendiri Institut Etika Harry Susilo dalam Ekonomi Global dan Direktur Proyek pembangunan rumah sakit JWCC Asih. Beliau adalah mitra pendiri Clay Kusuma (1999), sebuah perusahaan pengembangan dan manajemen proyek swasta di Indonesia dan Singapura.

Beliau terafiliasi dengan Ibu Finna Huang, Presiden Komisaris Perseroan.

On joining Sekar he served as president director of Bukit Welirang Indah (Finna Resort Redevelopment) (2016-2021) before becoming advisor to the shareholders. He is currently also the founder's representative to the Harry Susilo Institute for Ethics in the Global Economy and the Project Director of the JWCC Asih hospital development. He was a founding partner of Clay Kusuma (1999), a private project development and management company in Indonesia and Singapore.*
